

# **21-22 Verification Worksheet**

Your FAFSA was selected by the U.S. Dept. of Education for review in a process called *"verification"*. In this process, we are required by Federal law (34 CFR, Part 668) to compare the information from your application with the information provided on this form and with an IRS Tax Return Transcript of your 2019 Federal tax filing (and your spouse's if you are married, or parents' if you are considered dependent for Federal aid purposes). If there are differences between your FAFSA and the documents submitted, corrections will be made by our office. What you should do:

1. Collect your (and your spouse's or parents') financial documents (Tax Return Transcripts, 1040's, and/or W-2's)

2. <u>Complete all of the sections and sign the worksheet</u>. You (and a parent if you are required to provide parent income information) must complete all sections.

3. Contact the Office of Financial Aid with questions.
